Constitutional Changes:

Proposed constitutional changes to the Provincial constitution are as follows. Please read them and be prepared to vote on them at the April 26th meeting.

Resolution #1 - moved to strike Bylaw 5, section 3, Duties of the President and replace with:

President: chairs at executive meetings and the Convention.
 shall attend Board of Directors meetings.

Resolution #2 - moved to strike under Duties of the Secretary-Treasurer, sub section 1:

 ", " (after executive); "and the Board of Directors";
 and "the Convention".

 Sub section 2:

 strike "and the Board of Directors".

Resolution #3 - moved to strike Bylaw 6 in its entirety and replace with section from minutes:

 Responsibility for Constitution and Proceedings:

- a) the Provincial Secretary-Treasurer shall maintain at all times a current copy of the Constitution,
- b) printing and distribution of the Constitution shall be the responsibility of the Publicity Co-ordinator,
- c) Committee on Policy and Publications shall be responsible for the preparation of the final draft of the Proceedings.

Re-designate former Bylaw 6 as Bylaw 7.

Resolution #4 - Duties of the Vice-President:

- 1) liason
- 2) planning
- 3) professional education; provincial workshops; joint regional workshops and joint regional meetings.

Resolution #5 - strike Planning and Publicity Officer and replace with Publicity Co-ordinator.

Sub-section 1: shall be responsible for publicity.

We appologize that these changes are not accompanied by a copy of the Provincial Constitution but no one at the Directors meeting had an up-to-date copy. They are to be in the mail now to the local presidents so we hope to have at least one copy for reference at the next meeting.
