FIPPA AND YOU

How does the Ontario government's Freedom of Information and Protection of Privacy Act (FIPPA) affect you?

If you work for the provincial government, for one of its agencies, a community college, or a district health council, the provincial Act applies to your workplace. The Municipal FIPPA covers local government organizations (municipalities, school boards, public utilities, police commissions, fire departments, conservation authorities, and boards of health).

This legislation, which came into effect in 1988 at the provincial level and 1991 at the municipal level, provides everyone with the right of access to most recorded information held by government organizations. The <u>Directories of Records</u> outline the major banks of information held by institutions and these can be consulted in libraries and public offices.

In addition to providing the right of access to information, the legislation gives you the right to the protection of your own personal information that is held by government. Government organizations are not permitted to release personal information such as name, address, sex, age, education, medical or employment history to a third party.

Most government bodies need to collect personal information in

order to carry out their job functions. With FIPPA, though, it is important to look at the information we do collect and the reasons for it. It is also legislated that the organization who collects personal information must notify clients how it intends to use the information.

For example, a library may collect personal information (names, addresses, phone numbers) of library patrons. This information is required to contact clients about reserves or overdue books. However, if this is the purpose outlined, you do not need to record clients' ages or sex or social insurance numbers.

Additionally, you are not permitted to use the collected information for any other purpose or to release it to anyone else. Only those employees who need the information to perform their jobs may have access.

The Information and Privacy Commissioner (IPC) has the responsibility of ensuring the public has access to information held by government and that the individual's right of privacy is protected. The IPC publishes a series of information pamphlets on the Act. To obtain copies, call 1-800-387-0073.
