PROPOSED CONSTITUTION AMENDMENTS

Dear Members:

Just a short note to draw your attention to the following amendments to the TALTA Constitution. Please read them carefully because there will be a vote taken at the Annual Business Meeting to accept or reject the proposed amendments. Please remember to bring your copy of the Constitution to the Meeting.

TALTA Constitution Amendments

submitted February 1988

Your TALTA Executive, appointed to amend the constitution and by-laws, would respectfully submit the following, with the recommendation that they be adopted as revisions to the constitution and by-laws of this Association.

Article 5: Term of Office

- A) The term of office for President shall be one year. The President shall be succeeded by the Vice-President.
- B) (i) The term of office for Vice-President shall be one year followed by one year as President.
 - (ii) Valid nominations shall be sponsored by two (2) members, shall be submitted in writing to the Committee, and shall include the nominee's written consent to stand for Election.
 - (iii) The Committee shall file with the Executive members the names of all valid nominations.
 - (iv) Nominations will be accepted from the floor during the Annual Business Meeting.
- C) (i) Voting will be done in writing on an official ballot.
 - (ii) The Committee shall receive, count and tabulate all official Ballots cast.

- (iii) The Nominees receiving the largest number of votes for each position shall be elected.
- (iv) The Committee shall report the results of the Elections at the Annual Business Meeting.
